New Business	<p>Bylaw Change: The Board of Directors has voted and approved these changes.</p> <p>Article II Objectives Add "and to promote the proper boating safety and etiquette for all water recreational activities" to the sentence</p> <p>The purpose of this organization shall be to encourage the pursuit of sailing as a recreational activity and as a competitive sport; to teach the rules of sailing/ to engender a spirit of sportsmanship among its members, their families with in the community; to promote the teaching of the methods, techniques, sciences of sailing to young people; and to promote the proper boating safety and etiquette for all water recreational activities.</p> <p>Article VIII Board of Officers Remove Social Chairman, replace with Hobie Wave Chairman</p> <p>Add Hobie Wave Chairman shall oversee arrangements of the GPYC fleet of hobies; coordinating their launch/removal from the beach, conduct or coordinate any and all repairs needed, check the hobies in and out/maintain a list of people to conduct check ins.</p> <p><i>Formalize Treasurer shall be responsible for collection of all dues and any other amounts due the club. He will disburse club funds in payment of properly authorized club indebtedness at the direction of the Commodore, except that all expenditures in excess of \$300.00 will have prior approval of the Board of Officers. At the annual meeting following his election, he will submit a report of receipts and expenditures covering the fiscal year and the club's cash assets and liabilities at the years end. Records shall be kept up to date at all times.</i></p>
